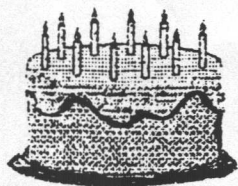
We hope you approve of the change in the Bulletin format. Thanks to those of you who have taken an ad space, to help with the publication cost.

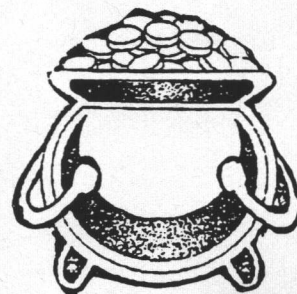

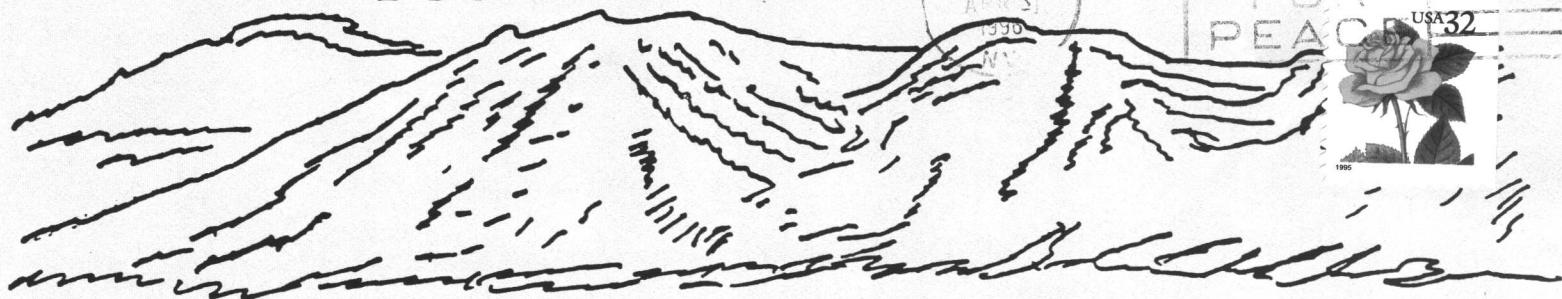

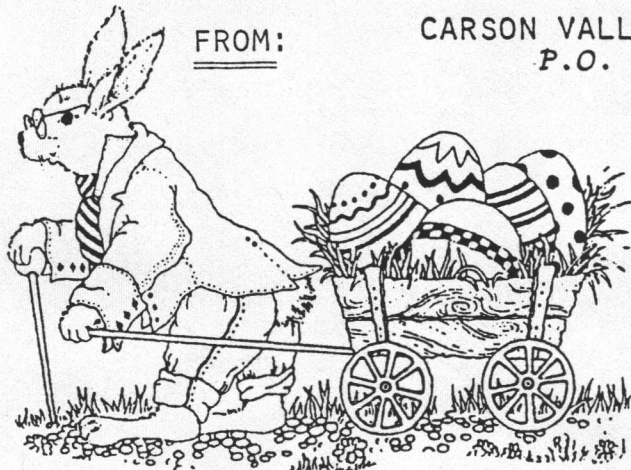
