Proposed new sentence to be added to By-Laws Article I - Officers, Board of Directors, Section 1.02: "A permanent position on the Board will be accorded to all Past Grand Presidents who are, or may become, regular members of this chapter."

The final decision on any such request or proposal rests with the membership."
