IFA History, Chapter 4

Annual conventions were held in cities where there were a large number of Footprint members. On June 6, 1935, at a meeting of the Board of Directors held in Los Angeles, California, it was voted to form the organization into chapters, each chapter so formed to be subordinate to the Grand Chapter, also formed at the same time as a governing body.

Secretary Geauque suggested the slogan "Bigger and Better Footprints," which stands for close cooperation between all law enforcement agencies, as well as the business and professional men. At the time of the formation of the Grand Chapter and the subordinate chapters, San Francisco was made Chapter No. 1 for the reason that it was San Francisco men principally who carried the early work on through its foolishness to where it began to be evident that the organization would grow with the foregoing ideals. Los Angeles was given No. 2, and all members in the vicinity of Los Angeles became members of that

chapter, and all members in the vicinity of San Francisco and elsewhere throughout the country became members of Chapter No. 1.

It developed later that a group from Los Angeles chartered a train, proceeded to Salt Lake City, Utah, and inaugurated and installed a chapter there, which became

known as No. 3. Some of the men who were already members belonging to Chapter 1 subsequently changed their membership to Chapter No. 3.

Because of the large number of Footprinters in Sacramento and vicinity, they were granted a charter and given No. 4. At that time, Chapter No. 1 had lost a great number of members.

Again, a special train was made up in Los Angeles, proceeding to Phoenix, Arizona, where a chapter was inaugurated and a Charter granted; their Chapter was known as No. 5.

About that time, Los Angeles had a membership of approximately 1.400 members. The next order of formation was Dunsmuir, California, known as No. 6, which has always remained a small chapter but which has always continued to be very active.

Because of the fact that there were so many members residing in Oakland and in the East Bay, they asked for and were granted a Charter, which was No. 7. They took several hundred members from the San Francisco chapter. Among them were many members of the Oakland Police Department, as well as the California Highway Patrol. Both Oakland PD and the CHP gained recognition when Inspector Elmer A. Steinmeyer of the CHP became the Grand President.


It was because of the withdrawals from the San Francisco Chapter No. 1 to Sacramento Chapter No. 4 and Oakland Chapter No. 7 that the membership of Chapter No. 1 dropped to a very low level. Additional chapters were organized and were numbered in order from 1 to 29, as of October 1950.
