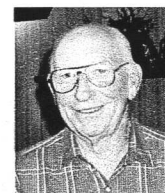

From the Secy/Treas.

First, a word about our dinner meeting prices. At the last Board of Directors meeting, we discussed this issue at length. We discussed the restaurants at which we regularly hold dinner meetings: the Carson Valley Inn, Topaz Lodge, Pinon Plaza and the Carson City Nugget. Those four currently charge us so that we can keep the costs to members at \$19 or less. We were told that the Carson Valley Inn has a new Food & Beverage manager, and that their prices may go up. Also, that frequently, most banquet restaurants tend to confer with each other – if one goes up, others can be expected to follow suit. We will continue to seek out the best meals at the lowest prices. The Board policy in setting prices for our members is this: we take the actual cost of the meals including tax and tip, and round up to the nearest whole dollar. This allows us to comp the guest speaker(s) without going in the hole. As an example, the last dinner at the Topaz Lodge cost us \$13.75 each; we charged our members \$14.

The "Pot of Gold" program is used rather extensively throughout all of the Footprint Association chapters as a fund raiser. In our chapter, we ask members to bring a little something for the drawing. We sell tickets at 6 for \$5; the drawing is held toward the end of the business meeting after dinner. The Pot of Gold, in our chapter, has traditionally been conducted by our Sergeant-at-Arms; probably because of the likelihood of unruly behavior when the prizes are delivered to the winners.....just kidding!!

Remember, the Nominations Committee has been named and will be working toward preparing a slate of officers and directors for your consideration for the next Footprinter year (7/1/01-6/30/02). Dick Upton is the chair of this committee; bring your ideas to Dick.

This coming June, our chapter will celebrate its 10th anniversary. The Board discussed having some kind of special celebration during the June meeting. Anyone with ideas, or who would like to chair or be on a committee to put this event together, should contact our president, Fred Hersey.

Our chapter is healthy, vibrant, solvent and growing, thanks to the participation and interest displayed by its members. Keep up the good work.

IFA History, Chapter 8

We pick up the action in 1968 with more new chapters being formed. In December 1968, Chapter 46 was installed in Beatrice, Nebraska. Known as the "First Homestead Chapter," there were 65 charter members with another 32 members joining soon thereafter. Grand President Joseph Forman conducted the installation.

As of April 1969, the following were the active chapters at that time:

In November 1971, Orange County Chapter 47 was installed in Anaheim, California by Jr. Past Grand President Elvin Sheehy. There were 50 charter members.

In January 1972, Pomona Chapter 48, known as the "Inland Empire Chapter," was installed by Grand President Vern Brook. There were 38 charter members. Also in January 1972, Kearney, Nebraska Chapter 49 was installed by Grand President Vern Brook with 53 names listed on the charter. Chapter 50 was held open for the Hawaiian Islands, which was then in the process of starting a chapter. In March 1972, Bellview, Nebraska Chapter 51 was installed, also by Grand President Vern Brook, with 52 charter members. Also in March 1972, Fort Collins, Colorado Chapter 52 was installed by Grand President Vern Brook, with 41 charter members. In April 1972, San Diego County Chapter 53 was installed by Grand President Vern Brook with 51 charter members. In May 1972, Bellingham, Washington Chapter 54 was installed by Grand President Vern Brook. In the five month period from January through May in 1972, Grand President Vern Brook installed 6 new chapters.

In April 1973, Tri-Cities Chapter 55 (Pasco, Richland and Kennewick, WA) was installed by Grand President John McAtee, with 41 charter members. In May 1973, Norfolk, Nebraska Chapter 56 was installed by Grand President John McAtee, with 25 charter members. In June 1973, Honolulu Chapter 50 was installed by Grand President John McAtee.

The next new chapter was in November 1974, with the installation of Lower Puget Sound Chapter 57 in Olympia, Washington.
