IFA History, Chapter 10

This chapter of our history will deviate somewhat from the format followed in the previous chapters. The last issue of the *Carson Valley Footprinter* followed our chronology through early 1982. In this issue, we will recap some of the highlights of our organization through the years.

#### **Bigger and Better Footprints**

Shortly after incorporation in 1932, then Secretary Phillip Geauque, a United States Secret Service agent from San Francisco, coined the phrase, "bigger and better footprints," to stand for "closer cooperation between all law enforcement agencies, as well as the business and professional People."

**Robinson Crusoe Logo** 

Michael J. Strazzo was the first Grand Historian for the International Footprint Association, Inc., and noted the following in his comments:

"The question has often been asked why the fictional story of Robinson Crusoe and his man Friday has been used in connection with this organization. Secretary Geauque, in the early days before there was any organization, thought that the fact that Robinson Crusoe discovered a footprint on the sands of the beach of the island where he was shipwrecked alone would be a good symbol. The footprint was that of Friday, who cooperated so nicely with Robinson Crusoe, and would be a very fitting symbol. Secretary Geauque, therefore, drew many cartoons of Robinson Crusoe discovering the footprints which led to Friday and those cartoons were circulated to a great extent, and subsequently were adopted after the organization became a going organization."

#### **Grand Chapter**

Although the Footprint Association was technically started in Fresno, California, in May 1929, and incorporated on January 26, 1932, the present organization, according to Grand Historian Strazzo, did not become official until June 1, 1935, when he noted the following:

"On June 1, 1935, a meeting of the officers of the Association was held in Los Angeles in the penthouse of Harry Fryman, atop the Hayward Hotel. At that time, Harry was police commissioner and it was there and then that we formed the Grand Chapter and four subordinate Chapters: San Francisco No. 1, Los Angeles No. 2, Salt Lake City No. 3, and Sacramento No. 4."

#### **Grand Secretary/Treasurer**

The offices of Grand Secretary and Grand Treasurer were filled by two different persons during the early years of Footprinter history. In 1959, the offices of Secretary and Treasurer were combined and Walter J. Vervais was elected Grand Secretary/Treasurer. He remained in that office until his retirement in 1982. At that time, after being an officer of the Grand Chapter for 37 years, Walter was granted the status of Secretary Emeritus and Ex-Officio member of each Committee of the Grand Chapter.

Carl Johnson was elected Grand Secretary/Treasurer at the Omaha, Nebraska convention in 1982 and was elected Grand Secretary/Treasurer Emeritus when he retired from that position in 1996. Carl Johnson currently serves on the Board of Directors of East Bay Chapter #7, and edits their bulletin.

Dick Thomson, East Bay Chapter #7, became the third Grand Secretary/Treasurer in 1996; being voted in by the membership at the Grand Convention in 1996.
