Ray's History Corner IFA HISTORY, circa 1938

The Grand Historian, Chuck Collins, has acquired a 1938 booklet containing some interesting facts with the regard to the eleven chapters that were in existence at that time. A synopsis of the information appears below:

Chapter #1 - San Francisco, CA Total membership = 427

Chapter #2 - Los Angeles, CA Total membership = 986

Chapter #3 - Salt Lake City, UT
Total membership = 158

Chapter #4 - Sacramento, CA
Total membership = 247

Chapter #5 - Phoenix, AZ
Total membership = 41

Chapter #6 - Dunsmuir, CA

Total membership = 44
Chapter #7 - Oakland, CA

Total membership = 345 Chapter #8 - Bakersfield, CA

Total membership = 66 Chapter #9 - Las Vegas, NV

Total membership = 95 Chapter #10 - San Jose, CA

Total membership = 133 Chapter #11 - Fresno, CA

Total membership = 117

Four of the first eleven chapters are now defunct; Phoenix, Dunsmuir, Las Vegas and San Jose. Membership numbers have changed dramatically among the remaining seven early chapters. The total membership in 1938, with only eleven chapters, was 2659. The total membership as of June 30, 2002, with 39 active chapters is 3389. An interesting side note: Bakersfield is the only chapter with a fixed membership (505); they have a waiting list to join! Everyone should be so lucky!


