The President's Message

Our June 15, 2008 meeting took place at the Carson Valley Inn located in the Town of Minden, Nevada. The meeting was called to order at 6:50 PM. Paul

Our Guests were introduced; District Fire Chief Tod Carlini, East Fork Fire and Paramedic Districts (our Guest Speaker) performed the duty of drawing a name for our Early Bird Dinner. For the benefit of all of our members, Tamara was unable to attend the meeting; however she did contact us and let her intentions be known prior to the deadline date. After having dinner, Chief Carlini presented his candidate, recently retired Deputy Chief Dave Drew to receive our quarterly Special Recognition Award. He

went on to explain what a dedicated public servant Dave had been over the years and that, he really did walk on water when it came to getting the job done. And, of course we all know it's the Dave Drews in this world that make things happen. It was an honor for me to present Dave with our Special Recognition Award plaque as this quarter's recipient. Congratulations on all of your successes Dave. All of us associated with the International Footprint Association, Carson Valley Chapter #72, wish you the very best in your well-earned retirement.

As our Guest Speaker Chief Carlini began his presentation by telling us what the East Fork Fire and Paramedic Districts are all about. His operations are involved with the following:

- Supports nine (9) Volunteer Fire Departments in the Carson Valley.
- Handles 5000 calls per year. The vast majority of which are Paramedic in nature.
- Covers 675 square miles with 14 fire stations.

• Supports nearby States with their fire fighting needs (personnel, equipment, etc., as the local work load permits.

Chief Carlini went on to describe the funding processes for his operations which include property tax and government grant revenues. He also acknowledged, with the down turn in the economy and the recently enacted property tax cap, monies in the future will just not be as available as in the past. This will mean he and his personnel will have to manage smarter and in a creative way, find new sources of revenue. This was a great presentation. At the conclusion of his presentation, I presented Chief Carlini with a certificate of appreciation for the free giving of his time to explain all of the East Fork Fire and Paramedic Districts operations.

At about 8:15 PM we turned our attention to Old Business. There being none, we moved to New Business:

Ray gave his Secretary-Treasurer's report, it was accepted as presented. He went on to let us know dues are coming due on July 1,
