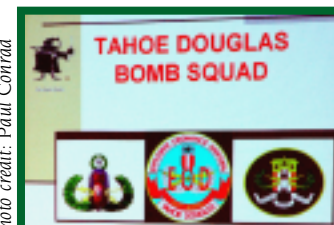

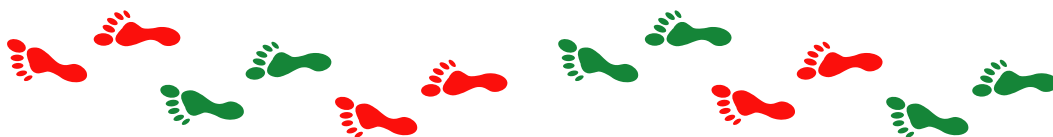

## *Important DMV Information*

In early October, the Nevada Department of Motor Vehicles will begin producing and issuing driver's licenses and identification cards from a secure, central location rather than at each of our 21 offices. We more commonly refer to the process as "Central Issuance" and will begin with our offices in Northern Nevada. By mid-November, the transition will be complete statewide. Because this change affects most Nevadans, the department feels it is important that you understand the process and why we decided to make this change.

When Nevada DMV customers renew their license or ID card, they will notice the first significant change when they leave the office with a paper-based interim document, good for up to 30 days, instead of a permanent card. The interim document is not a form of identification. The customer's previous driver's license or ID card will be invalidated by punching a hole through the expiration date and handed back to the customer to carry for identification purposes until the new card arrives. The new card will be mailed to the DMV customer within 10 business days.

When the new card arrives, a new look to the driver's license and ID card will be the second significant change motorists will notice. The redesign of the card is noticeable, but what won't be as obvious are the additional security features that make the card difficult to counterfeit. In fact, a Department of Homeland Security official called Nevada's new cards "...the most secure (driver's license) and identification cards in the United States in terms of counterfeiting."

Obviously, that is one of the reasons why the Nevada DMV is making the transition. Besides the new card being far more secure, the facility where the cards are produced is far more secure than a DMV office. At the production facility, employees must pass extensive background checks, and there are strict access controls to card-making materials and files.

There is also a behind-the-scenes advantage to issuing documents from a central facility. It gives the department the time to deploy facial recognition technology, making sure the person applying for a card doesn't already have a license or ID under a different name. Reducing fraud by making our cards as difficult as possible to counterfeit and reducing identity theft by making sure no motorist has more than one license or ID are the major benefits of issuing cards from a central location.
