The President's Message

It will be Thanksgiving this week and there is much we can be thankful about including for many of us: our health, not suffering hunger, homelessness, or violence as many in our world are now facing. What we are seeing, though; here at home is an increase in domestic

disobedience in the form of the Occupy Wall Street protests. While these protests started only a few months ago here in the US, they have rather ill defined objectives and have taken on many other protest targets other than just big banks and the Wall Street "fat cats". Over the last month, an anarchist fringe has joined forces with what started as a peaceful protest process; to now include rock and Molotov Cocktail launchings at police and the destruction of commercial property and looting, e.g. Oakland. (California) This last week we saw the student protests now trying to close down institutions of higher learning, e.g. Berkeley (California) and last week Davis (California). This gets me to the Davis incident of the mass Pepper spraying of the seemingly peaceful students just blocking a University entrance. Did it look bad for the police, yes of course, it certainly did. But you need to realize several things happened here: First, the officer who performed the spray down was not some lone wolf acting on his own volition at that moment. The decision had been made how to deal with these people above him. He was just the finger on the spray can trigger. Was this action a good idea, probably not in light of the resulting

public consequences? However, once a decision was made to clear the student body-chain, how could it best be done without any bad tactics being viewed nationwide? Experience has shown, when officers try to remove people en-mass by physical force, the protestors and often the police are injured, which costs both sides dearly and certainly more than just washing pepper spray out of eyes. We do not like to see officers clubbing or choking "peaceful" demonstrators. So, how do we deal with the incident? Experience has shown several ways which work better than mass pepper spray (which in this case didn't work at all!). Officers can be trained to apply subtle control holds and pain compliance techniques which do not show badly on news video but allows officers to remove one protestor at a time and clear the chain. LAPD and NYPD have had great results with their Mounted Units in moving people. Folks have a huge fear of horses and will move very quickly when a line of police horses bears down on them. Unfortunately, few jurisdictions have the resources to maintain a regular Mounted Unit, so they must revert to police officers dealing with protestors face to face. What must be considered and part of the plan (and there always has to be a plan) if protestors are to be removed is; how will it look on the 6pm news?


