Thursday April 17th at Carson City Nugget

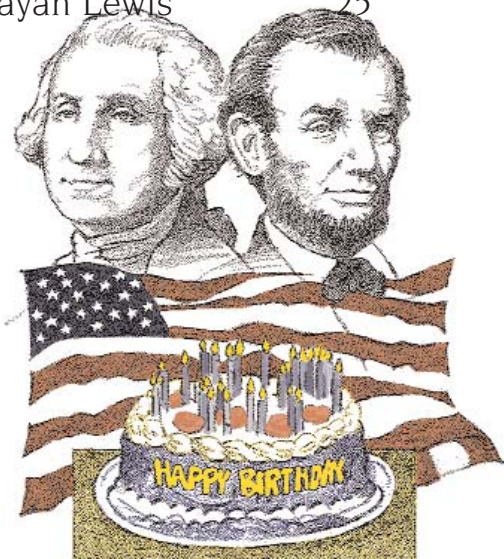
Thursday May 15th at Casino Fandango
