We will be front and center for October's meeting at the Carson Valley Inn in Minden for the Douglas County Search and Rescue Team's presentation.

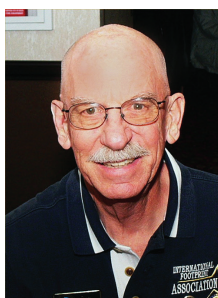


