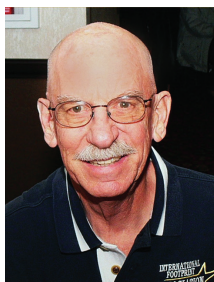

From the 1st Vice President

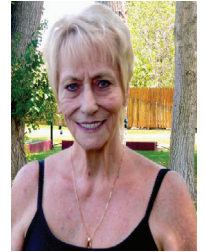
Happy New Year 2015 Footprinters, I hope you all had a wonderful holiday season and that your good health and prosperity will continue through the year 2015 and beyond.
