In the process and on the way out, he hit the planes tail and broke his back in three places, yet he survived. 3. Our Second new business item dealt with designating funds to be distributed to the Douglas County Sheriffs Office (DCSO). Douglas County Sheriff and IFA, Carson Valley Chapter #72 Board Director Ron Pierini explained the need for a Hand-held Amplifier for use in Crisis Negotiations, cost \$500.00. DCSO Captain and IFA, Carson Valley Chapter #72 Member Steve Orr reviewed the requirement for a Laser Distance Meter to be used for gathering evidence at crime scenes, cost \$449.00. He also advanced the need for some specialized communications equipment, cost \$1,350.00. DCSO Deputy and IFA, Carson Valley Chapter #72 Service Recognition Award Recipient Chris Griffith requested \$700.00 be provided to partially defray expenses associated with sending two DCSO Law Enforcement Explorers to attend the Federal Agency Academies in Washington DC. Out of 104 Explorers to be selected on a national basis, our two DCSO Explorers, Captain James Spencer and Lieutenant Shane Twitchell have been selected to attend the academies. I presided over the motion and vote process to fund the requests identified above totaling \$2,999.00. The attending members unanimously voted in favor of all four requests.

4. IFA, Carson Valley Chapter #72 has a new Internet Website, it is: www.cvfootprint.org. Try it out; tell a Board Member what you think. You will hear more about the rationale supporting this new communication means next month.
