At about 8:20 PM, there being no old business, we moved right into new business. Ray Hoyt gave the Secretary-Treasurer's Report and as always, it was accepted as presented. Still under new business, we then moved to item number two (2) on the agenda which dealt with your Chapter's annual 2008 project donation. Board member and the Sheriff of Douglas County Ron Perini presented your Board of Directors recommendation for a \$1,500.00 contribution. He informed the attending members, this money will be partnered with a like contribution from the Douglas County TRIAD organization for the purchase of a CARE TRACK unit. This transmitter/receiver unit is used by search personnel to locate Alzheimer and dementia patients

who turn up missing. Douglas County Sheriff's Deputy, Officer Bret Hicks who is also a TRIAD Board Member gave a short visual presentation demonstrating the effectiveness of the CARE TRACK device. Bret let us know that once a search person begins looking for the lost person, the average find time is 22 minutes. He further stated, this CARE TRACK unit can mean the difference between life and death. At the conclusion of Ron and Bret's presentation I put this Board of Directors recommendation to a vote by the attending members. This year's \$1,500.00 donation was unanimously approved as presented.

At about 8:40 PM we conducted our Pot of Gold raffle. Thanks go to our Greeters and raffle prize distributors Betty Miller, Judy Conrad and your Sergeant-at-Arms, Claudia Lowe. Your contributions at our meetings are the backbone of what makes our Chapter so successful.

Barbara and I announced our June scheduling and the meeting was adjourned at 8:55 PM.


