At our September Meeting, Brian Sandford, Editor of the Nevada Appeal was a really interesting speaker. He was very entertaining and appreciated by all attending.

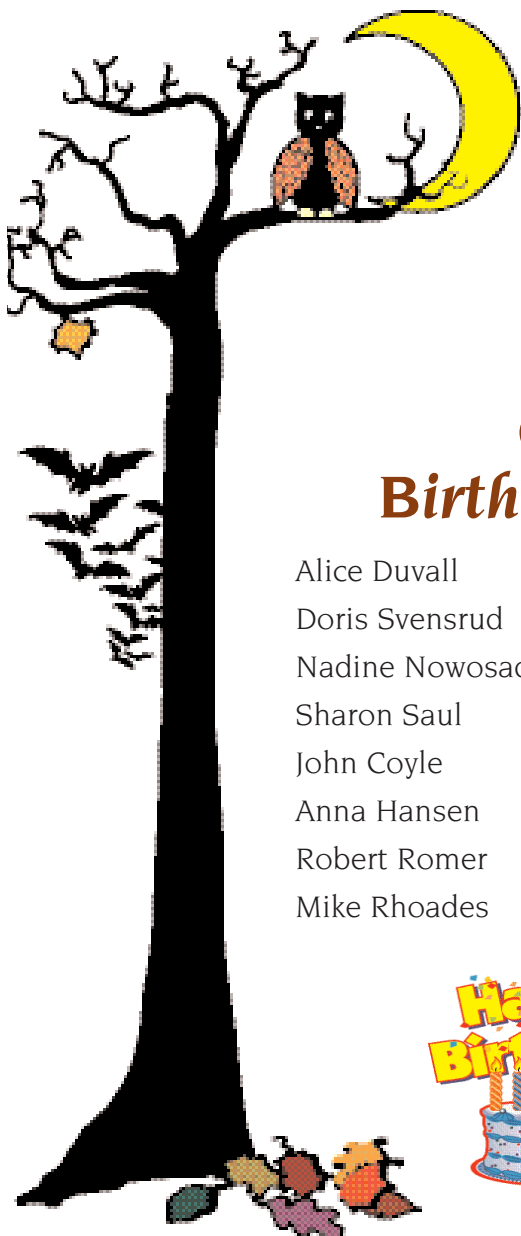
Our next meeting will be held on October 17th at the Carson Valley Inn, in the Town of Minden.
